



Notes for Guidance on Joining the Western Circuit

Joining the Western Circuit is by Election at one of the three Grand Nights held in the Michaelmas, Hilary and Trinity terms. Grand Nights are traditionally held in March, July and November in Bristol, Winchester and Exeter respectively. It is a condition of election that the applicant be a practising barrister and they attend the Grand Night on the occasion of their election. Their Proposer and Secunder are welcome to attend but it is not compulsory. The annual subscription is payable on election and thereafter annually on March 1st to cover the current year, 1st January to 31st December, at the rate of £75 for Juniors and £150 for Silks.

(NB Those elected in any year at Exeter Grand Night (November) are excused payment until the following March unless they wish to attend an education course after July in any year and wish to take advantage of the Circuit course rate. Any person taking silk is excused the uplift to the higher rate until the following year.)
